Situation question: READ CLOSELY:

Jack and Robert are refining 5 kilograms of gold ore. Jack first mouth-pipets 10 liters of 1 M solution of potassium cyanide/MDMA onto the ore. After heating the slurry in an industrial furnace and allowing the gold five minutes to complexate, Robert transfers the slurry into a George Foreman Aerogel Gravity Displacement Column and administers the tetrahydrocannabinol burn test. After the slurry partitions, the gold-containing component is dissolved in a solution of dihydrogen monoxide. Finally, 1 L of concentrated hydrochloric acid is added at once to the monoxide solution to obtain solid-state gold.
